The descriptive key below explains the meaning of the information in this List of Permitted Spill Cleanup Contractors:

Column Heading	Meaning of the Information in the Column
Permit No.	The spill cleanup contractor's Connecticut Hazardous Waste Transporter Permit Number.
EPA ID	The spill cleanup contractor's U.S. EPA ID Number.
Transporter Name	The spill cleanup contractor's company name as identified on their transporter permit.
Site Street Address	The spill cleanup contractor's site address.
Town	The town or city in which the permittee is located.
State	The state in which the permittee is located.
Phone No.	The phone number at which the permittee can be contacted.
PED	Permit Expiration Date (the date that the spill cleanup contractor's permit will expire).
N	A check mark means that the spill cleanup contractor is permitted to transport non-RCRA-hazardous CT Regulated Waste.
H	A check mark means that the spill cleanup contractor is permitted to transport hazardous waste.
SP	A check mark means that the company is permitted by DEEP as a spill cleanup contractor.

NOTE: Since all Connecticut waste transportation permits are vehicle and waste-specific, you should verify that the vehicle(s) to be used and wastes to be transported are listed on the spill cleanup contractor's permit before using their services.

This is only a partial listing of spill cleanup contractors that are permitted in Connecticut. This list has been established for general reference only and should not be used as an ultimate verification source (i.e., you may want to request a current copy of the spill cleanup contractor's permit from the hauler you intend to use). Please be aware that this listing may change from day to day; however, due to resource constraints, this list can only be updated from time to time. In addition, this list should not be construed to be a recommendation from the Waste Engineering & Enforcement Division of any services provided.
