

## State Police Arrest Two From Altercation At Mansfield Bar

On Saturday, December 13, 2003 at 11:53 pm the Connecticut State Police at Troop "C" were called to investigate an altercation at Huskies Bar located in Mansfield, Ct. The caller reported that a disturbance had taken place in the bar between two men and the bar staff, after the patrons were refused entry into the establishment.

Connecticut State Troopers and UCONN Police immediately responded to the scene to find the actual disturbance had ended. State Police Troopers began a on scene investigation to determine the events the chain of events that lead to the injury of one Husky's Staff member after being struck by a patron during the disturbance.

After conducting a extensive investigation, State Police personnel presented the facts and circumstances of this incident to the Tolland County Judicial District at the GA#19 Rockville Superior Court. Upon review the court issued arrest warrants for Peter Finch (22) and William Finch (48) both of #70 Crown Street in Bridgeport for actions during this altercation. This case is closed and no other arrest are anticipated.

Both men were processed according to State Police procedures and released on a written promise to appear. Both are scheduled to appear at the Rockville Superior Court on March 09, 2004.


