## **ASSAULT INVESTIGATION FROM THOMPSON, IS NOW A HOMICIDE \*SUSPECT BEING SOUGHT BY STATE POLICE\***

On Wednesday 09/07/2005 at approximately 9 P.M. Troop D in Danielson was notified of a disturbance involving several people behind an apartment complex located at 683 Riverside Drive (Rt. 12) in Thompson, CT. State Troopers responded to this disturbance and discovered 2 victims of an apparent assault. The victims (a male and female) received medical treatment at the scene and were transported to hospitals.

The State Police Major Crime Squad assumed the investigation of this assault. The State Police Detectives gathered evidence at the scene and interviewed several persons.

The male victim who was seriously injured was taken to UMASS Medical Center. That victim – Thomas O'NEIL age 56 d.o.b. 12/21/48 of Thompson, CT has since succumbed to his injuries.

As a result of the ongoing investigation the State Police now have an arrest warrant for Felony Murder, Murder, Assault 2<sup>nd</sup>, Conspiracy and Robbery for a CHRISTOPHER C. PELTIER, age 30 d.o.b. 08/08/1975 of the apartment complex located at #683 Riverside Drive, Thompson, CT. (see WANTED flier)

PELTIER has ties to the Webster, Oxford and Sutton MA area.


